Maintaining work and maximizing Medicaid benefits can be challenging for people with disabilities and/ or their family members. Michele discusses securing competitive employment while navigating and maintaining SSI/SSDI/Medicare/Medicaid, Home and Community Based Supports "Waivers," and how retirement planning impacts benefits. Laura breaks down hiring practices and supportive employment for people with neuro-diversities. Drew highlights Wawa's success in building out a supportive employment program for people with IDD in our region. The goal is to develop a foundation that is not exclusively dependent on state and federal support, but maximizes financial earning from jobs without sacrificing lifelong disability services and Medicaid benefits.

The state of Pennsylvania is struggling to find a way to properly fund and invest in public transit systems statewide. In the Philadelphia region, this has led to planned cuts and increased fares from SEPTA, which moves close to 750,000 people every day. Many of those riders are from the disability community and receive focused services and financial support to access the transit they need. This panel will examine the specific challenges faced by the community to maintain their hard-fought access, to adjust to loss of routes and services, and to ensure that the future includes a seat at the table for riders who can bring their experiences as people with disabilities into the decisions made affecting transit across the state–and specifically within SEPTA.

For the past year the Pennsylvania Tech Accelerator project, a group of more than 20 self-advocates, consumers, providers, and government agency officials, have been meeting and gathering information on creating administrative and public access systems that provide natural and flowing access to government services and information in Pennsylvania. The concept of Technology First, making universal access and accommodation the first issue to be addressed in the development and implementation of governmental interface with the public, is guiding this work. This hearing will provide an opportunity for public presentation of the report and recommendations of the Pennsylvania Tech Accelerator and possible draft legislation for Technology First initiatives that seek to improve accessibility to state government services for all residents of the Commonwealth, especially members of the disability community.
